The Board of Education of the Troy City School District met in regular session at the Troy Board of Education Office, 500 N. Market Street, Troy, Ohio 45373, at 5:30 P.M. on Monday, December 8, 2008. The President of the Board of Education, Mr. James Wilson, presided. Following the Pledge of Allegiance, Mr. Donald Pence, Treasurer, called the roll and the following members of the Board of Education were present: Mr. George Dearth, Mr. Stephen Lucas, Mrs. Joyce Reives, Mr. Doug Trostle and Mr. James Wilson. Also in attendance were Mr. Tom Dunn, Superintendent, four administrators and several visitors.

PRESENTATIONS

Eric Herman explained the courses of study that are currently being evaluated. They include Foreign Language (9-12), English (9-12), Art (K-12), Health and Physical Education (K-12) and Industrial Technology (7-8). He also reviewed the requirements of the Ohio CORE and what students have to accomplish to earn an Honors Diploma. He also noted that with a new state superintendent coming aboard and that state assessment program and academic content standards may be in flux.
