The Board of Education of the Troy City School District met in regular session at the Troy Board of Education Office, 500 N. Market Street, Troy, Ohio 45373, at 5:30 P.M. on Monday, May 11, 2009. The President of the Board of Education, Mrs. Joyce Reives, presided. Following the Pledge of Allegiance, Mr. Donald Pence, Treasurer, called the roll and the following members of the Board of Education were present: Mr. George Dearth, Mrs. Joyce Reives, Mr. Doug Trostle and Mr. James Wilson. Mr. Stephen Lucas was absent. Also in attendance were Mr. Tom Dunn, Superintendent, four administrators and several visitors.

MOMENT OF SILENCE

Natalie Howard Wheeler, 95, passed away peacefully at First Community Village, Columbus, Ohio, April 29, 2009. Born in Columbus, Ohio, Natalie graduated from the Columbus School for Girls, attended the Ohio State University, the Columbus Art School, graduated from Wittenberg University in 1959 and continued her academic pursuits with graduate studies at Miami University and The Ohio State University. She began her employment at Troy City Schools in 1959 and taught at Concord Elementary until her retirement in 1974.

PRESENTATIONS

- Carolyn Sargent, a sophomore at Troy High School, performed two songs on the viola. She was invited to play as a result of her invitation to play on a European tour this summer as part of the Blue Lake International Youth Symphony Orchestra. Carolyn was one of eighty-five selected from two thousand applicants. She briefly explained to the board how she became involved in this program. Also in attendance was Bruce George, a Troy citizen, who is active in promoting the performing arts in Troy and oversees the annual Mayor's Concert. Mr. George explained how he helped raise \$2000 from other people in Troy to help defray the costs of the trip. Dick Klockner, another supportive community member, also attended the meeting.
- Tom Dunn presented a Troy High School diploma to Veteran Arlen Reed. Mr. Reed explained how he quit school to join the service, serving during both the Korean and Vietnam Wars. He explained how he later earned his GED, but never received a high school diploma. In presenting the diploma to Mr. Reed, Mr. Dunn noted how it was the district's great honor to be able to award a Troy High School diploma to him for his service to our country.
- The Board held a small reception for this year's retirees prior to the meeting and then recognized the retirees in attendance. Each retiree was presented with a certificate of appreciation for their years of service and each was given the opportunity to address the board about his/her career in Troy. The adoption of the following resolution was moved by Mr. Dearth and seconded by Mr. Wilson:

“Whereas, school was cancelled at all of the schools operated by the Board of Education of the Troy City School District due to weather conditions; on Monday, September 15, 2008; Thursday, January 15; Friday, January 16; Wednesday, January 28; and Friday, January 30, 2009

“Whereas, Ohio Revised Code § 3317.01 allows schools to be cancelled for up to five days each school year due to public calamities including weather conditions with the approval of the State Superintendent of Public Instruction; and five days of school were cancelled in the Troy City School District during the 2008-2009 school year due to a public calamity; now, therefore

“Be it resolved by the Board of Education of the Troy City School District, a majority of its full membership therein concurring, that:

“Section 1. It requests the State Superintendent of Public Instruction to act pursuant to Ohio Revised Code § 3317.01 to waive Monday, September 15, 2008; Thursday, January 15; Friday, January 16; Wednesday, January 28; and Friday, January 30, 2009 as Days of Instruction due to weather conditions during the 2008-2009 school year at all of the schools in the Troy City School District.

“Section 2. It directs the Treasurer to certify and cause a copy of this resolution to be sent to the State Superintendent of Public Instruction.”

“Now, therefore be it resolved by the Board of Education of the Troy City School District, a majority of its full membership therein concurring, that this Board hereby finds and determines the bid of Sidney Electric Co, Sidney, Ohio, in the sum of \$237,500.00 is the lowest responsible bid received in accordance with the specifications for the Upgrade of the Mechanical Systems at Troy-Hayner Cultural Center and hereby awards a contract to Sidney Electric Co., 840 S. Vandemark Rd., Sidney, Ohio 45365 for this work and that the President, the Superintendent and the Treasurer are hereby authorized

and directed to execute a fiscal certificate to validate this contract as is required by Ohio Revised Code §5705.412, a copy of which certificate is attached hereto and incorporated herein by reference as Exhibit B.

The Board also approves the addition of two alternates and awards alternate H-3: Type "L" copper pipe at \$11,008.00 and Alternate H-4: Attic Fan Coil Unit FC-14 at \$4,115.00.

The Board also grants authority to the Superintendent to approve Change Orders up to the amount of \$10,000.00 to the contractors that are determined and required to complete the project.
