REGULAR MEETING

Board of Education Troy City School District 500 N. Market Street Troy, Ohio 45373 Monday, August 10, 2009 at 5:30 p.m.

The Board of Education of the Troy City School District met in regular session at the Troy Board of Education Office, 500 N. Market Street, Troy, Ohio 45373, at 5:30 P.M. on Monday, August 10, 2009. The President of the Board of Education, Mrs. Joyce Reives, presided. Following the Pledge of Allegiance, Mr. Donald Pence, Treasurer, called the roll and the following members of the Board of Education were present: Mr. George Dearth, Mr. Stephen Lucas, Mrs. Joyce Reives, Mr. Doug Trostle and Mr. James Wilson. Also in attendance were Mr. Tom Dunn, Superintendent, four administrators and several visitors.

MOMENT OF SILENCE

Delores K. Feaselman, 70 of Troy, died Sunday, July 5, 2009 at her residence.
 Delores "MaMa Dee" retired in 2003 after working 28 years as a Food Service Assistant in the Troy High School.

PRESENTATIONS

- Tom Dunn discussed the district's 2008-2009 State Report Card. He said the Ohio Department of Education was still manipulating data to determine the final school ratings, but, since this was the last board meeting prior to school beginning, it seemed appropriate to give an update on last year's student achievement. He noted that the district enjoyed its best performance ever based on the thirty indicators the state uses to rate school districts, earning twenty-nine of the thirty indicators. He said he was very proud of everyone's efforts and that students, parents, and staff should be very proud of that fact. He also told the board that our students performed better than ever on the performance index, earning 100.0 points. Both of these would place the district in the Excellent category. However, he also told the board that, because of the fact that No Child Left Behind and Adequate Yearly Progress causes students to be divided into subgroups with the expectation that all subgroups also perform according to state standards, it is possible that the district's final rating could range anywhere from Continuous Improvement to Excellent. He stated that the final rating will not change how we proceed this year. Even if we would be awarded the Excellent rating, our philosophy is that there is always room for improvement and if we would be given a Continuous Improvement rating, that doesn't change the fact that our students performed better than ever before and they have access to an excellent education.
- Tom Dunn provided a synopsis on House Bill 1 and the impact it may have on school districts. He discussed how he and Don Pence had attended a state budget meeting in Columbus earlier in the day and one thing became clear; school treasurers are expected to create a five-year financial forecast before the rules for the new legislation have even been written, making their jobs practically impossible. He talked about a few of the specifics of the new legislation, including the fact that Jarod's law had been repealed, which is of financial benefit to school districts, because that was a costly mandate. He also told the board that kindergarten students will be funded as 1 student rather than .5 student, like they have been in the past, but he also discussed how he wasn't sure how the district would meet the mandate for all-day, every day kindergarten beginning in 2010-2011 due primarily to space considerations. The fact is that there is not sufficient space to hold all-day kindergarten with our current configuration. He also noted that the district hates to move too quickly on some of these mandates because, as with Jarod's law, the mandate could be repealed in a subsequent budget law. Finally, he told the board that, with all the negative reports coming out of Columbus on the condition of the state budget, he doesn't understand why the legislature would be adding any programs until we weather this economic storm.
- Don Pence reviewed the progress of the summer capital projects, briefly noting the different projects that have occurred at each of the buildings.

• Eric Herman told the board that the district is working on creating a 7th grade class entitled "Understanding and Using Technology in our World," in response to state expectations.
