The Board of Education of the Troy City School District met in regular session at the Troy Board of Education Office, 500 N. Market Street, Troy, Ohio 45373, at 5:30 P.M. on Monday, November 16, 2009. The President of the Board of Education, Mrs. Joyce Reives, presided. Following the Pledge of Allegiance, Mr. Donald Pence, Treasurer, called the roll and the following members of the Board of Education were present: Mr. George Dearth, Mrs. Joyce Reives, and Mr. James Wilson. Mr. Doug Trostle and Mr. Stephen Lucas was absent. Also in attendance were Mr. Tom Dunn, Superintendent, three administrators and several visitors.

PRESENTATIONS

- Kathy McIntosh, Troy High School Marching Band Director, introduced Abby Daffner, senior band member, who was recently selected to the U.S. Army All-American Band. The band will play at halftime of the U.S. Army All-American Bowl in San Antonio, Texas, on January 9, 2010. Abby was one of 97 band members selected from more than 1000 applicants from around the United States. Mrs. McIntosh nominated her for this honor, then Abby had to complete an audition of playing and marching along with maintaining an excellent grade point average while performing community service. Abby will be leaving for San Antonio shortly after returning from London, England, where she will perform with the Troy High School Marching Band in London's New Year's Day parade.
- Cheryl Cotner, Executive Director of The Future Begins Today, explained to the board the many ways her organization supports Troy students. She also showed a nine-minute video during which a more detailed explanation was given. The video was created by Troy High School's Broadcast Journalism class, which was created by teacher Jeff Owen a few years ago. Mrs. Cotner explained that one of the key components of The Future Begins Today is the thousands of dollars of scholarships awarded annually to Troy students to further their educations.
- ♦ Eric Herman provided the board with an update on the Ohio Department of Education's (ODE) efforts to rewrite the academic content standards, as mandated by House Bill 1. Mr. Herman explained that the task is monumental, that the ODE has been unable, thus far, to meet the timelines it has established, and that with each presentation he attends conducted by the ODE, the information being provided to districts for their planning is changing. His goal was to make the board aware of the uncertainty surrounding changes in expectations from the state level and how difficult this uncertainty makes for districts who are all trying to plan for ways to meet future and different state expectations.
- During an informal presentation that was not on the agenda, Don Pence also provided the board with an overview of information he learned at the Ohio School Boards Association Capital Conference with respect to the state budget. He talked about the massive reductions in revenue collected at the state level and how Stimulus dollars have been used to balance its current budget. He also talked about the concern that already exists with the next biennial budget if Stimulus dollars will no longer be available.
- As another informal discussion topic, Tom Dunn talked to the board about the uncertainty that exists with the current mandate that all districts implement all-day kindergarten next year. There is currently legislation being proposed that would postpone that mandate for at least another year. While it sounds as if there is a good probability that this may happen, not knowing for sure what the expectation is going to be in this regard next year makes planning rather difficult.

RESOLUTION 09-105 ACCEPT BUS BIDS

"Whereas, specifications for the purchase of three buses were developed by the Southwest Ohio Educational Purchasing Council; and

"Whereas, legal advertisements were published in newspapers of general circulation on September 11, 2009 and September 18, 2009; and

"Whereas, the bids were publicly opened and read by the Southwest Ohio Educational Purchasing Council on November 2, 2009; and

"Whereas, a tabularized summary of this bid is attached hereto and incorporated herein by reference as Exhibit D therefore be it

"Resolved by the Board of Education of the Troy City School District, a majority of its full membership therein concurring, that

"Section 1. It purchase from Cardinal Bus Sales, one 72-passenger school bus and two 72 passenger handicap school buses at a total cost of \$281,233.00 less \$13,700.00 trade in allowance for three buses for a net cost of \$267,533.00.

"Section 2. It rejects all other bids received.

"Section 3. It directs that \$267,533.00 be paid to Cardinal Bus Sales as part of this transaction, upon delivery of the buses, expended from the American Recovery and Reinvestment Act (ARRA) stimulus funds for the two handicapped equipped buses and from the appropriated funds with the General Fund for the 72 passenger school bus.

"Section 4. It authorizes and directs the Treasurer, the Superintendent, the Transportation Supervisor, and the Business Manager to take all other steps as are appropriate to carry out this transaction."
