WHEREAS, on April 11, 2011, the Troy City Board of Education recommends and grants permission to the Superintendent to seek a waiver. Therefore, Be It

RESOLVED, That the Troy City Board of Education hereby recommends that the Superintendent seek a waiver for the delay of all-day, every-day kindergarten for the 2011-2012 and 2012-2013 school years.
